Dear valued member,

It is my hope that everyone is staying safe as we work through this unprecedented pandemic. As you know, the COVID-19 outbreak is changing rapidly and we are continuing to work through this situation the best we can. Our board of directors has met to discuss plans for the remainder of the competitive season. To date we have the following plan in place:

We are hoping to be able to resume training by April 6<sup>th</sup>, 2020. This potential start date will only happen under the directive of the Province of Nova Scotia and Gymnastics Nova Scotia. We will be processing payments for next month on April 1<sup>st</sup>. If you are a customer who pays at the desk monthly we ask that you please e-transfer the payment to [admin@cobequidspartans.ca](mailto:admin@cobequidspartans.ca) (use the password you already have set up otherwise please use "Spartans" as the password)

In the event we cannot reopen at that time, we will issue credits to your account for training fees only. Starting in April we will apply a credit each week that we are not able to start after April 6<sup>th</sup>, 2020. Fees that are currently in arrears will not receive any credits until fees are brought up to date. Furthermore, athletes will not be permitted back once training has resumed until fees are brought up to date. Any processed credits will remain on your account and may be used for next year (Sept 2020-Aug 2021).

With regards to meets; the Amherst March Break meet was cancelled, and the Provincial championships are postponed for now. Titans are still hopeful that they may host this event, however, if it does happen, it may not be until May or June. There are still many athletes have yet to pay the entrance fee for this event. In order to be registered for provincials our club has already pre-paid your registration fee a few weeks ago. At this point, regardless of whether Provincials are hosted or not, every athlete is responsible to pay the entrance fee. If the event is cancelled and we do in fact receive a refund, we will place the credit on your account.

Tickets will be distributed once we are able to return to class. In the event we are not able to open, you will receive a full refund/ credit for your tickets.

At this point we know for sure that two of the Nova Scotia Team travel events; Atlantics and Easterns have been cancelled for 2020. To date we have no information regarding Nationals.

We trust that you will accept this plan and continue to support our programs once we are able to open. We are all missing our gym family and hope to be together soon. Our board of directors will continue to meet and update this plan in the weeks to come.
